VS: Civilization is Always Re-Arriving

"Civilization" arrived in Europe too—even though that's supposedly the origin of all civilization. Really "civilizing" meant taking over land, destroying communal life, turning self-sufficient people into wage-dependent, subservient workers. This occurred simultaneously with the colonization of the New World, and it especially involved the suppression of women, and ultimately, across time, their subjugation as inferior to men, but economically subservient to them, and locked within homes doing labor that is socially devalued as "not real work."

Federici, as you should recall, views the whole period from say 1500-1800 as a process of "proletarianization" and the "primitive accumulation" of land, wealth, and labor.

Capitalism/the spread of colonization... systematically involves the **PRODUCTION OF SCARCITY**

While its ideology boasts of its superior productivity, it actually means **increased starvation for all the working class**, especially because so much production is done for the international market, and capitalism incentivizes hoarding. In the 1600s in particular there is intense resistance especially on the part of women.

STATES also grow more and more powerful and violent through this period. Armies grow 10x in size

They go from temporary and unprofessional to permanent and professional Wealthy CAPITALISTS INVEST IN WAR

Large scale use of foreign mercenaries with no connection to people in their localities.

WAR CHANGES THE LANDSCAPE... later in the book Federici shows how war opens land to privatization. This is one of many (capitalist) factors driving war in the global south today.

It all starts with PRIVATIZATION OF LAND (typically by force)... But it really means the DESTRUCTION OF COMMUNITY, DEMOCRACY, SOLIDARITY Europe: 1480→

- Evictions of tenants
- Rent increases
- Increased state taxes → debt and sale of land...
- Then the ENCLOSURES (1500s 1800, repeatedly): pushing people off common land—loss of access to meadows, ponds, woods, open spaces... mutual ability for subsistence, cooperation of workers, collective decision making

Removal of the COMMONS = removal of the MATERIAL FOUNDATION OF SOLIDARITY AND SOCIALITY... especially for women

(**Perhaps this is what is needed again? A material foundation for solidarity and sociality. That is: COMMON SPACE / COMMON LAND.)

Once people are robbed of common land, and the practices of joint work and joint decision-making are made impossible, competition between them emerges

The social-ethical fabric is attacked and destroyed.

1500s-1600s Europe... families disintegrate

Guilds are broken, as is artisanal independence

... WORKERS BECOME DEPENDENT

Then their pay is cut

Their days are lengthened

They have to work 2x as many days... as Saints' days are removed Production (of products for market \rightarrow of capital) now becomes "men's work" BECAUSE to have wage labor work, you have to have somebody at home to REPRODUCE that labor, as well as the labor force across time. Now REPRODUCTION (of the worker, of children)... is "women's work."

So check out this interesting opposition. It looks a lot like the "Society vs. State"-Primitive Society vs. "Society for the State"-"Civilization" opposition we saw before, and the opposition of anti-colonial-indigenous vs. "Western" values from earlier:
